 Notice is hereby given that 18<sup>th</sup> Annual General Meeting (AGM) of the Company will be held on **Wednesday, August 14, 2024 at 10.30 AM (IST) through Video Conference (VC) / Other Audio-Visual Means (OAVM)** to transact the business as set out in the Notice of AGM dated May 30, 2024 in compliance with the applicable provisions of the Companies Act, 2013 and its rules framed thereunder and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with the relevant circulars issued by the Ministry of Corporate Affairs (MCA) and the Securities and Exchange Board of India (SEBI) from time to time. Further, in accordance with the MCA/SEBI Circulars, the Notice of AGM/Annual Report for Financial Year 2023-24 has been sent to all the shareholders whose email addresses are registered with the Company / Depositories as on Wednesday, July 17, 2024.

Members can attend and participate in the Annual General Meeting through VCOAVM facility only by following procedure as set out in the Notice of the AGM.

In compliance with Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended from time to time and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Members are provided with the facility to cast their votes on all the resolutions set forth in the Notice of the AGM using remote electronic voting system ("remote e-voting") provided by Link Intime India Private Limited (LIPL). Additionally, the Company is providing the facility of voting through e-voting system during the Annual General Meeting ("e-voting").
